The total investment necessary to begin operation of an AmeriSpec franchise ranges from: \$60,050 to \$72,310 (for a new franchise) and \$53,550 to \$65,310 (for a conversion franchise). This includes \$28,800 that must be paid to the franchisor.

2. WE MAY TERMINATE YOUR FRANCHISE AGREEMENT IF YOU DO NOT REACH CERTAIN REVENUES AND MARKET SHARE IN YOUR BUSINESS IF YOUR AGREEMENT WITH US HAS GROWTH REQUIREMENTS.
