An "Amsterdam Falafelshop" franchise is a restaurant business using a distinctive and innovative system specializing in falafels, self-serve garnishes, salads and toppings, twice-cooked Dutch-style fries, and other menu items

The total investment necessary to begin operation of an "Amsterdam Falafelshop" franchise is \$364,300 to \$539,900. This includes \$29,500 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

***1 THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION OR LITIGATION ONLY IN DELAWARE. OUT OF STATE MEDIATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO MEDIATE OR LITIGATE WITH US IN DELAWARE THAN IN YOUR OWN STATE.**

***2 THE FRANCHISE AGREEMENT PROVIDES THAT DELAWARE LAW GOVERNS THE AGREEMENT, EXCEPT TO THE EXTENT THAT THE LANHAM ACT GOVERNS. DELAWARE LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.**

3 YOU ARE NOT PERMITTED TO ENGAGE IN OFF PREMISES CATERING SERVICES OR DELIVERY SERVICES. WE AND OUR AFFILIATES MAY ESTABLISH AMSTERDAM FALAFELSHOP COMPANY OWNED OR FRANCHISE OUTLETS AND OTHER FOOD SERVICE FACILITIES IN MALLS, STADIUMS, SCHOOLS, AIRPORTS, HOSPITALS, AND SIMILAR CAPTIVE AUDIENCE FACILITIES WITHIN THE PROTECTED TERRITORY OF THE DEVELOPER OR FRANCHISE, WHICH MAY COMPETE WITH THE FRANCHISE RESTAURANT.

4 UPON EARLY TERMINATION OF THE FRANCHISE, YOU ARE LIABLE TO PAY US LIQUIDATED DAMAGES IN AN AMOUNT EQUAL TO YOUR AVERAGE MONTHLY ROYALTY FEES AND SYSTEM FUND CONTRIBUTIONS DUE US DURING THE OPERATION OF YOUR FRANCHISE MULTIPLIED BY 36 MONTHS OR THE NUMBER OF MONTHS REMAINING IN THE FRANCHISE AGREEMENT, WHICHEVER IS LESS.

5 AS OF THE DATE OF THIS DISCLOSURE DOCUMENT, OUR PARENT OPERATES ONE OF FOUR AMSTERDAM FALAFELSHOP RESTAURANTS IN OPERATION AND GUARANTEES THE PERFORMANCE OF OUR OBLIGATIONS UNDER THE FRANCHISE AGREEMENT. OUR PARENT'S AUDITED FINANCIAL STATEMENTS SHOW THAT AS OF DECEMBER 31, 2013, IT HAD A WORKING CAPITAL DEFICIENCY OF \$91,422, AN ACCUMULATED LOSS FROM OPERATIONS OF \$ 373,569, AND A DEFICIT IN RETAINED EARNINGS OF \$202,319.

6 THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

* Local law may supersede these agreement provisions. Certain states require the superseding provisions to appear in an addendum to this Disclosure Document (see Exhibits H and I).

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you.
