FALAFELSHOP INC.'S AUDITED FINANCIAL STATEMENTS SHOW THAT AS OF DECEMBER 31, 2016 IT HAD A WORKING CAPITAL DEFICIENCY OF \$122,299, AN ACCUMULATED LOSS FROM OPERATIONS OF \$657,169, AND A DEFICIT IN RETAINED EARNINGS OF \$107,175. THIS MAY ENTAIL ADDITIONAL RISK OF FINANCIAL LOSS AND YOU MAY WANT TO TAKE THIS INTO CONSIDERATION WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPORTUNITY.

5. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$366,300 to \$513,400. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDER'S EQUITY OF (\$107,175) AS OF DECEMBER 31, 2016.
