The franchised business is to operate a specialty rental vehicle service under the trade name "Arcimoto"

The total investment necessary to begin operation of a Arcimoto franchise is \$273,900 to \$509,000 This includes \$195,000 to \$345,000 that must be paid to the franchisor or affiliate The total investment necessary to begin operation under a three- to five-unit Multi-Unit Development Agreement is \$349,900 to \$644,000 in addition to the initial investment to open a single Arcimoto Franchise This includes \$270,000 to \$475,000 that must be paid to the franchisor There is no minimum number of Arcimoto units that you are required to develop under the Multi-Unit Development Agreement
