## FRANCHISE DISCLOSURE DOCUMENT

This Franchise Disclosure Document describes the franchise concepts offered by AVF Franchising, LLC, a retail store business offering to the general public home and office furniture, mattresses, flooring, window treatments and other related items under the AVF Franchising, LLC licensed Marks and Franchise System. Our franchises will be sold as either: (i) an Individual Unit Franchise, or (ii) to qualified persons, the exclusive right may be granted to select and develop an agreed upon number of franchise sites within a certain geographical and defined period of time.

The total investment necessary to begin operation of an AVF Franchising, LLC franchised business ranges from \$1,067,524 to \$3,899,550. This includes an initial franchise fee of \$375,000.00 - \$505,000.00 paid to us or our Affiliate. The total investment necessary to begin operation of an AVF Franchising, LLC Area Development Franchise for a 3 unit development commitment ranges from \$1,100,024 to \$3,934,550. The Area Development Fee is determined by multiplying \$10,000 times the number of units to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English, Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
