The Franchise offered is for a quick service restaurant known as "Asian Chao®" which features a wide variety of Oriental dishes, including a large selection of chicken, beef, and seafood dishes along with Chinese favorites such as Sweet N Sour Chicken, Beef with Broccoli, Lo Mein, and a variety of vegetarian tofu dishes.

The tota, investment necessary to begin operation of an Asian Chao franchised business is 401,500 to 706,400. This includes between 35,900 to 86,400 that must be paid to the franchisor and/or its affiliate, as appropriate.

If You enter into a development agreement to develop more than three restaurants, You will pay a development fee of \$15,000 per restaurant to be developed under the development agreement, and You will pay a franchise fee of \$15,000 for each of the first three, and a reduced fee of \$10,000 for each unit after that to be developed under the terms of the development agreement. The development fee is applied <u>pro rata</u> to the franchise fees due.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
