CALLRN Franchise LLC offers franchises for the operation of a business that assists seniors and their families in locating assisted living facilities, senior housing options and care services that meet their geographic, financial and clinical needs and preferences.

The total investment necessary to begin operation of an Assisted Living Locators franchise ranges from \$59,300 to \$70,250. This includes \$49,500 that must be paid to us.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

1. THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS BE SETTLED BY ARBITRATION OR LITIGATION IN ARIZONA. OUT-OF-STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN ARIZONA THAN IN YOUR HOME STATE.
2. THE FRANCHISE AGREEMENT STATES THAT ARIZONA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. AS PER THE AUDITED BALANCE SHEET DATED MARCH ~~6, 2014~~22, 2015, WE HAD NET WORTH EQUITY OF ~~\$52,146~~12,459 AS OF DECEMBER 31, ~~2013~~2014.
4. THE FRANCHISE AGREEMENT REQUIRES THAT SPOUSES OF FRANCHISE OWNERS EXECUTE A PERSONAL GUARANTY, PLACING THEIR PERSONAL ASSETS AT RISK.

THE FRANCHISE AGREEMENT REQUIRES THAT AFTER YOU HAVE BEEN OPEN FOR BUSINESS FOR TWELVE (12) MONTHS, YOU MUST PLACE AT LEAST 18 NEW CLIENTS IN EACH SIX (6) MONTH PERIOD FOLLOWING THE START OF THIS MINIMUM PERFORMANCE REQUIREMENT. IF YOU DO NOT ACHIEVE THIS MINIMUM PERFORMANCE REQUIREMENT, WE CAN MODIFY YOUR TERRITORY, PERMIT OURSELF, OTHER FRANCHISEES (NEW OR EXISTING) OR AFFILIATES TO OFFER SERVICES WITHIN YOUR TERRITORY, OR WE CAN TERMINATE YOUR FRANCHISE.
6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
