The franchisee will operate an Atax tax return preparation business, consisting of one or more Offices (which may be developed over time under an Area Development Agreement) that will provide tax preparation services and related products to individuals and businesses

The total investment necessary to begin operation of one Atax Franchise that is a New Business is from \$37,450 to \$76,800, including \$17,499 plus \$8,500 for each additional Business that you agree to open under an Area Development Agreement that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of an Atax franchise that is a Converted Business is from \$12,650 to \$36,000, including \$2,500 to \$7,500 plus \$8,500 for each additional Business that you agree to open under an Area Development Agreement that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

- 1 THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY LITIGATION ONLY IN THE STATE, COUNTY AND JUDICIAL DISTRICT IN WHICH OUR PRINCIPAL PLACE OF BUSINESS IS THEN LOCATED, WHICH IS CURRENTLY WESTCHESTER COUNTY IN THE STATE OF NEW YORK. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN THE STATE, COUNTY AND JUDICIAL DISTRICT IN WHICH OUR PRINCIPAL PLACE OF BUSINESS IS THEN LOCATED THAN IN YOUR OWN STATE.
- 2 THE AREA DEVELOPMENT AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY NONBINDING MEDIATION ONLY, AT OUR PRINCIPAL PLACE OF BUSINESS (WHICH IS CURRENTLY IN WESTCHESTER COUNTY, NEW YORK), PRIOR TO COMMENCING ANY LEGAL ACTION. OUT OF STATE MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE WITH US IN NEW YORK THAN IN YOUR OWN STATE.
