The franchise is to operate an “ATC Healthcare Services” Franchised Business that provides medical professional temporary and permanent staffing solutions to healthcare facilities. We offer both start-up and conversion franchises.

The total investment necessary to begin operation of a start-up ATC Healthcare Services single unit franchised business is \$132,020 to \$219,820 This includes between \$57,620 to \$62,620 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of an ATC Healthcare Services multiple unit discount package is \$185,520 to \$582,320. This includes between \$112,620 to \$117,620 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of a conversion franchise is \$19,420 to \$75,820. The total initial investment for two virtual offices would be \$27,500-\$66,000.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
