Both ranges include \$69,000.00 to \$89,000.00 that must be paid to the franchisor or affiliate.

The terms of your contract will govern your franchise relationship. Do not rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.
