CHANGES TO DISCLOSURE DOCUMENT REQUIRED BY THE STATE OF CALIFORNIA

In recognition of the requirements of the California Administrative Doce, Title 10, Chapter 3, subchapter 2 6, sections 310 00 through 310 505 and the California Business and Professions Code, Section 20000 through 20043, the Disclosure Document of Baby Boot Camp, LLC for use in the State of California shall be amended as follows

1 The cover page shall be supplemented with the addition of the following language

THE CALIFORNIA FRANCHISE INVESTMENT LAW REQUIRES THAT A COPY OF ALL PROPOSED AGREEMENTS RELATING TO THE SALE OF THE FRANCHISE BE DELIVERED TOGETHER WITH THIS DISCLOSURE DOCUMENT

CALIFORNIA BUSINESS AND PROFESSION CODE SECTIONS 20000 THROUGH 20043 PROVIDE RIGHTS TO THE FRANCHISEE CONCERNING TERMINATION OR NON-RENEWAL OF A FRANCHISE IF THE FRANCHISE AGREEMENT CONTAINS A PROVISION THAT IS INCONSISTENT WITH THE LAW, THE LAW WILL CONTROL

THE FRANCHISE AGREEMENT CONTAINS PROVISIONS THAT LIMIT FRANCHISEE'S RIGHTS AND MAY NOT BE ENFORCEABLE IN CALIFORNIA INCLUDING BUT NOT LIMITED TO A TIME LIMIT TO RAISE CLAIMS AGAINST THE FRANCHISOR, LIMITATION OF DAMAGES AND WAIVER OF JURY TRIAL

THE FRANCHISE AGREEMENT CONTAINS A LIQUIDATED DAMAGES CLAUSE UNDER CALIFORNIA CIVIL CODE 1671, CERTAIN LIQUIDATED DAMAGES CLAUSES ARE UNENFORCEÄBLE

THE FRANCHISE AGREEMENT REQUIRES BINDING ARBITRATION THE ABRITRATION WILL OCCUR IN SARASOTA, FLORIDA WITH THE COSTS OF ARBITRATION BEING BORNE BY EACH PARTY AS INCURRED

2 The last paragraph of the cover page shall be amended to read as follows

Registration of this franchise with any state does not mean that the state recommends it or has verified the information in this Disclosure Document. If you learn that anything in this Disclosure Document is untrue, contact the Federal Trade Commission and the California Department of Corporations, at any of its offices.

3 Item 3, entitled "Litigation", shall be supplemented with the addition of the following language

Neither we nor any person or franchise broker identified in Item 2 of this FDD is subject to any currently effective order of any national securities association or national securities exchange, as
