As a Bacon Bitch franchisee, you will operate a fast-casual gourmet restaurant specializing in classic breakfast sandwiches

The total investment necessary to begin operation of a Bacon Bitch franchised business ranges from \$270,00 to \$389,000. This includes \$35,000 which must be paid to the franchisor or affiliate. The total investment necessary to begin operation of an Area Development Business for 3-5 outlets ranges from \$305,000 to \$459,000. This includes \$70,000 to \$105,000 that must be paid to the franchisor or affiliate. You may purchase additional outlets for \$17,500 each.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
