The franchise offered is for the establishment and operation of a real estate brokerage business that provides its customers with exceptional real estate and realtor services. Franchises will be established as conversions of an existing business offering services that complement those offered by the franchise.

The total investment necessary to begin operations of a Baird & Warner conversion franchise is \$57,000 to \$275,100. This includes \$25,000 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
