The franchisee will operate a restaurant under the name Bambu Desserts and Drinks[™] featuring desserts, drinks, waffles, snow ice/shaved ice, pre-packaged food, and other Asian-inspired food and drink items. The total initial investment necessary to begin operations ranges from \$110,500 to \$242,400. This includes \$70,000 to \$80,000 that must be paid to the franchisor or an affiliate.

You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
