The franchisee will operate an authentic, Southern-style barbecue restaurant featuring genuine smoked barbecue in a setting reminiscent of the "Old West" under the trademark "Bandana's Bar-B-Q".

The total investment necessary to begin operation of a Bandana's Bar-B-Q restaurant is from \$380,200 to \$1,122,500. This includes \$40,000 that must be paid to the franchisor or its affiliates. If you are granted area development rights under an Area Development Agreement, you will pay a Development Fee of \$10,000 per number of Bandana's Bar-B-Q restaurants you agree to develop.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your disclosure document in another format that is more convenient for you.
