The Charter Practice operator ("You") will operate, or enter into arrangements for the operation of, a full-service veterinary pet hospital (a "Hospital") under the name and mark "Banfield<sup>®</sup> Pet Hospital." In most instances, the Hospital You operate will be located in or adjacent to a PetSmart retail store.

The total investment necessary to begin operation of a Banfield Charter Practice hospital franchise ranges from approximately \$236,500 -\$508,000. This includes \$65,000 that must be paid to Charter Practices International, LLC. This disclosure document summarizes certain provisions of Your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before You sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

The terms of Your contract will govern Your franchise relationship. Don't rely on the disclosure document alone to understand Your contract. Read all of Your contract carefully. Show Your contract and this disclosure document to an advisor, like a lawyer or an accountant.
