The franchise offered in connection with this disclosure document is for the establishment and operation of BAR-B-CUTIE, a fast casual, family restaurant specializing in Bar-B-Q Pork, Grilled Chicken, Baby Back Ribs, and other foods.

The total investment necessary to begin operation of a Bar-B-Cutie franchised business is estimated to range from Four Hundred Eight Thousand Nine Hundred Ten Dollars (\$408,910) to Five Hundred Thousand Two Hundred One Dollars (\$500,201). This includes Thirty Thousand Dollars (\$30,000) that must be paid to the franchisor or its affiliates.

The disclosure document is also for the establishment and operation of BAR-B-CUTIE SMOKEHOUSE, a fast casual, family restaurant specializing in Bar-B-Q, limited food items and craft beer.

The total investment necessary to begin operation of a Bar-B-Cutie Smokehouse franchised business is estimated to range from Four Hundred Eight Thousand One Hundred Seventy Seven Dollars (\$408,177) to Five Hundred Twenty Seven Thousand Six Hundred Thirty Nine Dollars (\$527,639). This includes Thirty Thousand Dollars (\$30,000) that must be paid to the franchisor or its affiliates.
