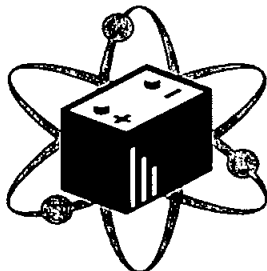

You will operate a Business that sells and services batteries and related products to retail consumers and commercial customers. You will provide these services operating under the Marks and using the System. The Initial Franchise Fee is \$29,900. The estimated required initial investment ranges from 192,450 to \$257,690. These figures are approximate and do not include land and building costs.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you can sign a binding agreement with, or make any payment to Us or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.** You may wish to receive your disclosure document in another format that is more convenient for you. 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO MEDIATE AND ARBITRATE DISPUTES WITH US AND TO CONDUCT THE MEDIATION AND/OR ARBITRATION IN MICHIGAN. OUT OF STATE DISPUTE RESOLUTION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND/OR ARBITRATE WITH US IN MICHIGAN THAN IN YOUR OWN STATE.

YOU WILL BE REQUIRED TO MAKE AN INITIAL INVESTMENT RANGING FROM \$192,450 TO \$257,690. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDERS EQUITY AS OF DECEMBER 31, 2011, WHICH WAS NEGATIVE 73,720.
