Battery Giant Franchise LLC offers individual and multiple unit franchises that sells and services batteries and related products to retail consumers and commercial customers. You will provide these services operating under the Marks and using the System. The total investment necessary to begin operation of a Battery Giant is \$212,220 to \$332,550 that will be paid to us or our affiliates or other vendors. This includes the Initial Franchise Fee of \$29,900 and opening equipment, fixture and inventory Kit Fees of \$149,900 that must be paid to us or our affiliates. These figures are approximate and do not include land and building costs. If you sign an Area Development Agreement, you also must pay to us \$10,000 for each store you commit to develop.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you can sign a binding agreement with, or make any payment to, the franchisor on an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

You may wish to receive your disclosure document in another format that is more convenient for you. 1. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT REQUIRES YOU TO MEDIATE AND ARBITRATE DISPUTES WITH US AND TO CONDUCT THE MEDIATION AND/OR ARBITRATION IN OAKLAND COUNTY MICHIGAN. OUT OF STATE DISPUTE RESOLUTION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND/OR ARBITRATE WITH US IN MICHIGAN THAN IN YOUR OWN STATE.

THE FRANCHISE AGREEMENT STATES THAT MICHIGAN LAW GOVERNS THE AGREEMENT; AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

2. AS A RELATIVELY NEW COMPANY, THE FRANCHISOR HAS A LIMITED OPERATING HISTORY. YOU MAY WISH TO CONSIDER THIS IN YOUR DECISION. YOU WILL BE REQUIRED TO MAKE AN INITIAL INVESTMENT RANGING FROM \$213,720 TO \$342,550. THIS AMOUNT EXCEEDS THE FRANCHISOR’S STOCKHOLDERS EQUITY AS OF DECEMBER 31, 2014, WHICH WAS NEGATIVE \$68,206.
3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE
