The franchisee will operate a Becoming Balanced Hormonal Metabolic Correction center, offering the Becoming Balanced Hormonal Metabolic Correction program, under the name BeBalanced Hormone Weight Loss Centers.

The total investment necessary to begin operation of a BeBalanced Hormone Weight Loss Centers franchise at single location ranges from \$122,412 to \$176,712. This includes \$49,000 - \$54,000 that must be paid to the franchisor or its affiliate(s).

A three-location option is available and you may open three BeBalanced Hormone Weight Loss Centers franchises. The total investment necessary to open three locations ranges from \$329,236 to \$491,336. This includes \$35,000 - \$40,000 for the second location and \$25,000 - \$30,000 for the third location that must be paid to the franchisor, or its affiliate(s).

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
