The franchise is a home-based heat specialist business dedicated to serving customers that have an infestation problem and are looking for alternatives to traditional pest control techniques and harmful products, under the name "BedBug ChasersTM". The total estimated initial investment required for a BedBug ChasersTM Franchise ranges from \$99,425 to \$143,550 depending on a number of factors that are more fully discussed in Item 7. This includes the Initial Franchise Fee of \$25,000 (as discussed in Item 5) that must be paid to the Franchisor or our affiliate.


