The franchise is for the right to develop, own and operate a retail store specializing in the sale of premium Taiwanese Boba Tea beverages and Baos, which are steamed, soft, sweet buns stuffed with fresh ingredients such as barbecued pork, chicken, vegetables and dessert fillings. Bee & Tea stores offer a variety of complementary snack foods and beverages with flavorings, sweeteners and topping choices for each guest's Boba Tea. Bee & Tea Inc. may also offer qualified candidates the right, under a Multi-Unit Agreement, to acquire multiple franchises

The total investment necessary to begin operation of a Bee & Tea Store ranges from \$147,500 to \$287,100 This sum includes \$49,300 to \$57,600 payable to us or our affiliates. The total investment will increase if the franchisee chooses to enter into a Multi-Unit Agreement for multiple franchises, the increase being as follows. For a 3 unit agreement the total investment will increase by \$275,000 to \$554,200. For a 4 unit agreement, the total investment will increase by \$402,500 to \$821,300. For a 5 unit agreement, the total investment will increase by \$520,000 to \$1,078,400.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, Bee & Tea Inc. or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

- 6 YOU WILL NOT RECEIVE AN EXCLUSIVE TERRITORY YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM OUTLETS THAT WE OWN OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS THAT WE CONTROL
