The franchise offered is a Bee Hive Homes facility providing assisted living and/or residential care of persons not requiring skilled nursing care.

(1) The total investment necessary to begin operation of a Bee Hive Homes franchise is approximately ~~\$850,000~~ \$1,200,000 to ~~\$2,000,000~~ \$2,000,000. This includes \$500,000 that must be paid to the franchisor and its affiliates.

(2) This Franchise Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. You must receive this Franchise Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
