The franchise is the right to own and operate a business that provides, through a mobile shop and at customers' locations, service and repair of bicycles, parts and accessories, sale of new bicycles and, at our direction, service, repair and sale of other personal recreational items and related services under the "Beeline Bikes<sup>®</sup>" name and marks.

The total investment necessary to begin operation of a Beeline Bikes business is estimated to be \$78,200 to \$132,750. This includes \$26,250 paid to franchisor or its affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH THE FRANCHISOR IN CALIFORNIA, THAN IN YOUR HOME STATE.**
