The franchise offered is a plumbing maintenance, repair and replacement, and drain cleaning services franchised business.

The total investment necessary to begin operation of a Benjamin Franklin Plumbing conversion franchised business is \$89,805 to \$257,512. This includes \$45,120 to \$50,515 that must be paid to the franchisor or its affiliates. It does not include fees for a territory with a population of greater than the minimum 100,000, for which we charge an additional \$430 for each 1,000 of population above 100,000. The total investment necessary to begin operation of a Benjamin Franklin Plumbing start-up franchised business is \$219,805 to \$427,112. This includes \$45,120 to \$47,115 that must be paid to the franchisor or its affiliates.
