Ben's Barketplace businesses operate retail health food pet stores that offer premium-quality pet food, toys and related products, and information and education to pet owners on the proper diet, health and well-being of their pets ("Ben's Barketplace Business(es)").

The total investment necessary to begin operation of a single Ben's Barketplace Business ranges from \$188,550 to \$360,550, including \$33,750 and \$45,000 which must be paid to the franchisor or its affiliates.
