The franchisee will engage in the business of preparing and selling foods from one or more BENTO SUSHI Counters at a grocery store, retail center, or other location owned by someone else.

The total initial investment necessary to begin operation of a Bento Sushi Full Service Location ranges from \$18,975 - \$206,200, including \$9,725 to \$172,700 you must pay the franchisor or its affiliates. The total initial investment necessary to begin operation of a Commissary-Based Bento Sushi Operation ranges from \$26,075 - \$240,950, including \$16,825 to \$207,450 you must pay the franchisor or its affiliates. The total initial investment necessary to begin operation of a Bento Sushi Limited Service Location ranges from \$13,075 - \$161,050, including \$5,325 to \$134,050 you must pay the franchisor or its affiliates. The total initial investment necessary to begin operation of a Bento Sushi Satellite Location ranges from \$2,300 to \$109,250, including \$1,100 to \$103,000 you must pay the franchisor or its affiliates. The total initial investment necessary to purchase an existing Bento Sushi Counter ranges from \$20,095 to \$216,200, including \$11,725 to \$182,700 you must pay the franchisor or its affiliates.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

Here are some questions you may be asking about buying a franchise and tips on how to find more information:

QUESTION	WHERE TO FIND INFORMATION
How much can I earn?	Item 19 may give you information about outlet sales, costs, profits or losses. You should also try to obtain this information from others, like current and former franchisees. You can find their names and contact information in Item 20 or Exhibits E and F.
How much will I need to invest?	Items 5 and 6 list fees you will be paying to the franchisor or at the franchisor's direction. Item 7 lists the initial investment to open. Item 8 describes the suppliers you must use.
Does the franchisor have the financial ability to provide support to my business?	Item 21 or Exhibit B includes financial statements. Review these statements carefully.
Is the franchise system stable, growing, or shrinking?	Item 20 summarizes the recent history of the number of company-owned and franchised outlets.
Will my business be the only Bento Sushi business in my area?	Item 12 and the "territory" provisions in the franchise agreement describe whether the franchisor and other franchisees can compete with you.
Does the franchisor have a troubled legal history?	Items 3 and 4 tell you whether the franchisor or its management have been involved in material litigation or bankruptcy proceedings.
What's it like to be a Bento Sushi franchisee?	Item 20 or Exhibits E and F list current and former franchisees. You can contact them to ask about their experiences.
