Brief Description of the franchised business: The franchised business is a restaurant concept specializing in pasta dishes and other food and beverage items.

The total investment necessary to begin operation of a BENVENUTO'S franchise is \$1,091,500 to \$4,582,500. This includes \$75,000 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 1. The franchise agreement requires you to resolve disputes with us by arbitration only in Wisconsin. Out-of-state arbitration may force you to accept a less favorable settlement for disputes. It may also cost you more to arbitrate with us in Wisconsin than in your own state.
- 2. The franchise agreement states that Wisconsin Law governs the agreement, and this law may not provide the same protections and benefits as local law. You may want to compare these laws.
- 3. There may be other risks concerning this franchise.
