The total investment necessary to begin operation of a Best In Class Education Center franchise ranges from ~~\$69,500~~56,700 to ~~\$114,100~~96,800. This includes ~~\$29,150~~ to ~~\$32,600~~150 that must be paid to us and our affiliate.
