Franchisor, Go Beyond, Ltd. dba Beyond Studios ("GoBeyond" or "Beyond Studios"), is an edgy and innovative fitness franchise with a Pilates based concept at its core. GoBeyond also offers several other types of group fitness workouts in cycling, as well as the Beyond500 proprietary workout which is designed to allow participants to burn 500 calories in a 50 minute class. These classes are designed to be fresh, current and relevant to both the instructors teaching the classes and the participants enrolled in the classes. GoBeyond strives to incorporate the best of traditional Pilates and cardio into the custom designed workouts offered at its fitness studios. Each of our exercise series is an innovative, intense, results-driven workout that strengthens core muscle groups, burns fat and creates lean, toned muscles. GoBeyond studios offer cutting edge equipment that the instructors incorporate into the Beyond workouts to reach the maximum potential for each participant!

The total investment necessary to begin operation of a GoBeyond franchise is \$151,000 up to \$415,000 dollars. This sum includes the initial franchise fee of \$30,000 dollars, initial retail inventory costs of \$3,000, a \$1,500 Digital Online Customization Fee and instructor certification fees (price will vary depending on the number of additional instructors that need certification) that must be paid to the franchisor or affiliate.
