Single Store Program Under the Single Beyond Vape Store Program, you will sign a Franchise Agreement to operate a single Beyond Vape Store The total investment necessary to begin operations of a single Beyond Vape Store ranges from approximately \$142,070 to \$331,660 This includes between \$38,000 and \$55,000 that must be paid to us or our affiliate

Area Development Program Under the Area Development Program, we assign a defined area within which you must develop and operate a minimum of 2 Beyond Vape Stores within a specified period of time. The total investment necessary to begin operations of 2 to 4 Beyond Vape Stores under an Area Development Agreement ranges from approximately \$154,070 to \$361,660. This includes between \$48,000 and \$75,000 that must be paid to us or our affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale.
