The franchise being offered is an automotive aftermarket service business dealing in the sale and installation of mufflers and the repair of exhaust systems, the sales, installation and replacement of brakes; selling and installing shocks and struts; and the sales, installation, and service of constant velocity joints (c.v. joints) for front wheel drive vehicles.

The total investment necessary to begin operation of a Big Al's franchise is between \$99,875 to \$248,500. This includes \$15,000 that must be paid to the Franchisor or affiliate. This sum also includes rent for the business location.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise grant or sale. **Note, however, that no governmental agency has verified the information contained in this document.**
