We grant you the right to operate a Big Fish Little Fish Restaurant. Your Restaurant will feature proprietary recipes and other products in a distinctive atmosphere. The franchise business is a Poke concept (Hawaiian fish salad) dressed with multiple toppings (green onions, sesame oil and soy sauce) and served on rice or salad. You can customize and build your own or choose from one of the signature bowls which include: big eye tuna with classic sesame-soy sauce, green onions, cucumber, radish sprouts and pickled ginger; salmon with yuzu kosho, maui onion, crispy onion and wasabi peas; spicy tuna with harissa garlic aioli, pickled cauliflower, pomegranate and avocado; snapper with ponzu sauce; shrimp with chili lime vinaigrette, cilantro, mango, avocado and coconut flakes.

We also grant to qualified franchisees the right to develop multiple Big Fish Little Fish Restaurants under a Multi-Unit Agreement.

The total investment necessary to begin operation of your Restaurant is from \$296,450 to \$378,950. This includes \$44,950 to \$46,450 that must be paid to us. The total investment necessary to begin operation under a Multi-Unit Agreement is from \$386,450 to \$503,950. This includes \$139,750 to \$141,250 that must be paid to us.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

THE FRANCHISE AGREEMENT AND MULTI UNIT AGREEMENT REQUIRE YOU RESOLVE DISPUTES WITH US BY LITIGATION/ARBITRATION/MEDIATION ONLY IN CALIFORNIA, OUT-OF-STATE LITIGATION/ARBITRATION/MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES IT MAY ALSO COST YOU MORE TO LITIGATE/ARBITRATE/MEDIATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.
- 2. YOU DO NOT RECEIVE AN EXCLUSIVE TERRITORY WE CAN COMPETE WITH YOU IN NON-TRADITIONAL (SPECIAL SITE) LOCATIONS AND IN ALTERNATE CHANNELS OF DISTRIBUTION.
- 3. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
- 4. WE DO NOT HAVE A FEDERAL REGISTRATION FOR OUR PRINCIPAL TRADEMARK. THERFORE, OUR TRADEMARK DOES NOT HAVE AS MANY LEGAL BENEFITS AND RIGHTS AS A FEDERALLY REGISTERED TRADEMARK. IF OUR RIGHT TO USE THE TRADEMARK IS CHALLENGED, YOU MAY HAVE TO CHANGE TO AN ALTERNATIVE TRADEMARK, WHICH MAY INCREASE YOUR EXPENSES.
- 5. THE FRANCHISOR HAS BEEN OFFERING FRANCHISES FOR A SHORT PERIOD OF TIME. THERFORE, THERE IS ONLY A BRIEF OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT.
- 6. THE FRANCHISE AGREEMENT CONTAINS PROVISIONS THAT LIMIT YOUR RIGHTS AND MAY NOT BE ENFORCEABLE IN ALL STATES, INCLUDING BUT NOT LIMITED TO A LIMITAION OF DAMAGES AND A WAIVER OF YOUR RIGHT TO A JURY TRIAL.
- 7. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
