The BIGGBY® COFFEE franchise is a neighborhood cafe offering espresso based beverages, coffee, tea, other beverages, salads, sandwiches and baked goods, whole bean coffee, merchandise and coffee accessories.

The total investment necessary to begin operation of a BIGGBY[®] COFFEE franchise is from \$160,350 to \$317,100. This includes \$15,000 to \$28,500 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provision of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
