The franchise offered is for the establishment and operation of an at-home business providing residential and commercial removal of regulated bio medical waste with additional services such as cleaning, disinfecting, hoarding remediation, medical waste and sharps removal and repair of damaged structural areas.

The estimated total investment to begin operations of a Bio-One Inc. franchise is 83,750 to \$89,850. This includes \$35,000 initial franchise free that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before You can sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
