You, the franchisee, will operate a Birch Tree Academy franchise in a designated Territory, operating a school offering preschool learning programs and care for children with a STEM-based curriculum and a bilingual program, using the "Birch Tree Academy" name and system.

The total investment necessary to begin operation of a single Birch Tree Academy Franchise is between \$712,250 to \$1,478,000 for a new franchise. See Items 5, 6, and 7 which more fully describes the initial investments.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully.
