BizCard Xpress businesses provide extremely fast printing and sign services to the general public in as little as one hour, and offer a complete array of business and promotional products and services (“BizCard Xpress Business”). BizCard Xpress regional developers (“Regional Developers”) market and provide support services to BizCard Xpress Businesses in a designated area (“Regional Developer Franchise”) and also operate a BizCard Xpress Business (a “Pilot Location”).

The total investment necessary to begin operation of a BizCard Xpress franchise ranges from \$108,046 to \$209,575, including \$90,046 to \$142,275 which must be paid to the franchisor or its affiliates.

The total investment necessary to begin operation of a BizCard Xpress Regional Developer Franchise, which includes the cost to open and operate a Pilot Location, ranges from \$210,546 to \$545,420, including between \$171,046 and \$441,320 that must be paid to the franchisor or its affiliates.

This franchise disclosure document summarizes certain provisions of your franchise agreement and other information in plain English (“Franchise Disclosure Document”). Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment in connection with the franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

Your state may have a franchise law that requires a franchisor to register or file with a state franchise administrator before offering or selling in your state. MANY FRANCHISE AGREEMENTS DO NOT ALLOW YOU TO RENEW UNCONDITIONALLY AFTER THE INITIAL TERM EXPIRES. YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT AND THE REGIONAL DEVELOPER AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION/LITIGATION ONLY IN FLORIDA. OUT-OF-STATE ARBITRATION/LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE/LITIGATE WITH US IN FLORIDA THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT AND REGIONAL DEVELOPER AGREEMENT STATE THAT FLORIDA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THE FRANCHISE AGREEMENT AND REGIONAL DEVELOPER AGREEMENT REQUIRE THAT SPOUSES MUST SIGN A GUARANTY MAKING SUCH SPOUSE JOINTLY AND SEVERALLY LIABLE FOR THE OBLIGATION UNDER THE AGREEMENT PLACING PERSONAL ASSETS AT RISK.
4. THE FRANCHISOR RESERVES THE RIGHT TO ESTABLISH MINIMUM AND MAXIMUM RESALE PRICES FOR MARKETING AND SPECIAL PRICE PROMOTIONS.
5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
