BBDI LLC grants franchises for the operation of family-style restaurants which offer signature entrees featuring huge portions under the name Black Bear Diner.®

The total investment necessary to begin operation of a single Black Bear Diner restaurant is \$912,800 to \$1,804,200. This includes \$24,000 to \$55,000 which must be paid to us for the Franchise Fee. We also offer an opportunity to operate multiple Black Bear Diner restaurants under an Area Development Agreement. The estimated initial investment to operate as an Area Developer ranges from \$987,300 to \$1,878,700. This includes a Franchise Fee of \$55,000 and a Development Fee of \$72,200 which must be paid to us. If you are an existing franchisee, we may grant you the right to enter into an Option Agreement for the right to develop a single Black Bear Diner restaurant at a predetermined site. The amount of the Option Fee is \$10,000 and is paid to us. The total investment is the same as for a single Black Bear Diner restaurant.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
