Thank you for your response. The following still needs to be addressed:

- The Minnesota Commissioner of Commerce must be designated on the Consent to Service of Process.
- ✍ Item 7: for the line item "Uniforms", state the method of payment, the due date and to whom payment will be made. (comment #5)
- ✍ Exhibit A: please remove "Market Assurance Division" and enter "Securities Unit". (comment #9)
- ✍ The fee deferral language added to the Addendum to Disclosure Document needs to be amended to state "All fees paid by you to us, including payments ..." (not "by us by you") .
