The franchisee will operate a plumbing and drain repair business under the name BLUEFROG PLUMBING + DRAIN<sup>®</sup>

The total estimated investment necessary to begin operation of a start-up BLUEFROG PLUMBING + DRAIN<sup>®</sup> franchise ranges from \$69,430 to \$340,510. This includes \$14,000 to \$122,495 that must be paid to us. The total estimated investment necessary to begin operation of a conversion BLUEFROG PLUMBING + DRAIN<sup>®</sup> franchise (i.e., if you are converting an existing plumbing and drain repair business) ranges from \$16,430 to \$190,510. This includes \$6,000 to \$62,000 that must be paid to us.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

4. **THE FRANCHISEE WILL BE REQUIRED TO MAKE AN INITIAL INVESTMENT RANGING FROM \$69,430 TO \$340,510 (FOR START-UP FRANCHISES) AND \$16,430 TO \$190,510 (FOR CONVERSION FRANCHISES). AS NOTED IN THE FINANCIAL STATEMENTS, THE FRANCHISOR'S PARENT COMPANY AND GUARANTOR (FRANZ BRANZ HOLDINGS, LLC) IS A NEW ENTITY WITH A LIMITED RECORD OF PERFORMANCE. A PROSPECTIVE FRANCHISEE SHOULD CAREFULLY REVIEW THE FINANCIAL STATEMENTS AND BEAR THIS IN MIND WHEN FORMING ITS INVESTMENT DECISION.**
5. **THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.**
