a) Plaintiff claimed the defendants allegedly failed to pay for equipment purchases and allegedly failed to reimburse amounts paid by AT&T for deactivated subscribers and for security deposits. On April 29, 2008, Plaintiff and Defendants reached a Settlement Agreement whereby Defendants agreed to pay Plaintiff \$800,000 without admitting any fault or wrongdoing. The Settlement Agreement covered both this case and the AT&T Mobility, LLC v. Cellular Warehouse, Inc. et al case filed in Nevada discussed below.

b) Plaintiff claimed the defendants allegedly failed to pay for equipment purchases and allegedly failed to reimburse amounts paid by AT&T for deactivated subscribers and for security deposits.
