At BONANZA STEAKHOUSE, guests have enjoyed both the superb quality of a buffet and a broad array of great tasting, high quality, affordably priced steak, chicken and seafood entrées. Our buffet features a large variety of all you can eat salads, soups, appetizers, vegetables, breads, hot main courses, and desserts. BONANZA STEAK & BBQ is a full service steakhouse with a fresh farm-to-table salad bar, and a menu showcase of USDA flame-grilled steaks and house-smoked BBQ, with contemporized interpretations of traditional American classics.

The estimated total investment necessary to begin operation of a Bonanza Steakhouse® or Bonanza Steak & BBQ® single-unit franchised business location ranges from \$251,300 to \$987,100. This includes the Initial Fee that must be paid to the franchisor or its affiliate. If you enter into a Development Agreement (“DA”), the Exclusive Territory Fee may range from \$40,000 to \$500,000 to develop 2 to 25 restaurants. The total investment necessary under a Development Agreement to open a single restaurant and have development rights for between 2 to 25 restaurants within an Exclusive Territory is \$291,300 to \$1,487,100.
