The initial franchise fee is \$30,000 00 The franchisor at times also offers to franchise existing stores. The franchise fee for a corporate store purchased from the franchisor ranges from zero to \$30,000 00 and is based upon the gross sales of the store. The total initial investment necessary to begin operation of a Bonfare franchise is \$122,000 00 to \$186,000 00. This includes the initial franchise fee described in Item 5 that must be paid to the franchisor or affiliate.
