The franchise described in this document is being offered by the franchisor to franchisees to operate a retail grocery store under the name "Bonfare<sup>®</sup>."

The initial franchise fee is \$30,000.00. The franchisor at times also offers to franchise existing stores. The franchise fee for a corporate store purchased from the franchisor ranges from zero to \$30,000.00 and is based upon the gross sales of the store. The total initial investment necessary to begin operation of a Bonfare<sup>®</sup> franchise is \$162,000.00 to \$236,000.00. This includes the initial franchise fee described in Item 5 that must be paid to the franchisor or affiliate.

This disclosure document <u>summarizes</u> certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payments to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

2. THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. THE FRANCHISOR MAY TERMINATE YOUR GASOLINE LEASE AT ANY TIME FOR ANY REASON.

4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
