The franchise offered is for a quick-serve, casual restaurant offering a menu specializing in gourmet sandwiches, soups, salads, desserts and soft drinks which are complemented by a line of specialty hot, iced or frozen drinks, as well as a line of gourmet coffees by the pound and other coffee products under the name "Boston Coffeehouse®". A Boston Coffeehouse® restaurant offers breakfast and lunch menus for dine-in, take-out and catering, and operates using the franchisor's proprietary recipes, formulae, techniques, trade dress, trademarks and logos.

The total investment necessary to begin operation of a Boston Coffeehouse® franchise is \$175,050 to \$300,800. This includes \$25,000 that must be paid to the franchisor and/or its affiliate, as appropriate. Please see Items 5 and 7 for additional details.

If you enter into a Multi-Unit Operator Agreement to develop at least three Restaurants, when you sign the Multi-Unit Operator Agreement you will pay a multi-unit operator fee equal to \$25,000 for the first Restaurant to be developed plus a deposit of \$10,000 multiplied by each additional Restaurant to be developed under the Multi-Unit Operator Agreement. The multi-unit operator fee is applied properator to the initial franchise fees due.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale.
