You will operate a brake repair and service store that also offers lube, oil and filter services

The total investment necessary to begin operations of a Brake Masters Systems, Inc.'s franchised business ranges from \$167,450 to \$298,950 for someone having an existing automotive repair business, and from \$227,200 to \$652,150 for a start-up business. These estimates do not include real estate expenses. This includes the initial franchise fee of \$22,950, and pre-opening purchases ranging from \$0 to \$193,609, that must be paid to our affiliates or us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
