The Franchisor is SPROUSE FITNESS LLC, dba BRICKHOUSE CARDIO CLUB ("Brickhouse" or "we"). We develop, operate, and franchise BRICKHOUSE CARDIO CLUB fitness studios. Our franchised studios provide cardio-oriented fitness classes.

The total investment necessary to begin operation of a Brickhouse franchise ranges from \$13,750 to \$23,750. This includes a range of \$9,900 to \$14,900 that must be paid to the franchisor (financing is available). This amount does not include any real estate renovations or costs. This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
