As a franchisee, you will operate a specialty toy store offering high-quality, enriching products and aesthetic appeal.

The total investment necessary to begin operation of a Brilliant Sky franchised business is \$216,000 to \$429,000. This includes \$55,000 to \$65,000 that must be paid to the franchisor.

OUT-OF-STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN TENNESSEE THAN IN YOUR OWN STATE.
