*Broadway Pizza* Broadway Bar & Pizza®, and Broadway Pizza® Express Restaurants are railroad theme pizza restaurants which offer the public high quality food and beverages of <u>a</u> distinctive character and quality under the name Broadway Pizza®, Broadway Bar & Pizza®, and Broadway Pizza® Express.

The total investment necessary to begin operation of a traditional *Broadway Pizza*® or *Broadway Bar & Pizza*® franchise ranges from \$479,500 to \$5934,000. This includes the initial fee of \$525,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a *Broadway Pizza*® *eExpress* limited service franchise is \$15136,400 to \$5356,500. This includes the initial fee of \$15,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
