The franchisee will operate a family-style restaurant under the trade name and service mark "Buffalo Wings & Rings "

The estimated initial investment required ranges from \$1,244,000 to \$3,085,000. If you are not currently opening one or more Buffalo Wings & Rings restaurants, this includes \$35,000 (if you sign a Franchise Agreement for a newly-constructed restaurant before September 1, 2016) or \$40,000 (if you sign a Franchise Agreement for a newly-constructed restaurant on or after September 1, 2016) that must be paid to the franchisor Buffalo Wings & Rings, LLC. If you are currently operating one or more Buffalo Wings & Rings restaurants, this includes \$25,000 (if you sign a Franchise Agreement for a newly-constructed restaurant before September 1, 2016) or \$30,000 (if you sign a Franchise Agreement for a newly constructed restaurant on or after September 1, 2016) that must be paid to the franchisor Buffalo Wings & Rings, LLC. If you are purchasing a restaurant which is currently in operation, this includes \$20,000 that must be paid to the franchisor Buffalo Wings & Rings, LLC. These sums do not include the cost of acquiring or leasing the business location and may not include the full cost of acquiring an alcoholic beverage license or financing costs. The state of California has required that we defer receipt of this initial franchise fee from you until all our obligations to you have been completed and your restaurant is open for business.

In addition to individual restaurant franchises, Buffalo Wings & Rings LLC offers Area Development Agreements.

Area Development Agreements grant you the right to develop at least three Franchised Restaurants within a specified territory according to a negotiated schedule. The development fee is \$70,000 for a minimum of three Franchised Restaurants that you must open during the term of the Area Development Agreement. The State of California has required that we defer receipt of this Development Fee from you until all our obligations to you have been completed and your first restaurant is open for business. The estimated initial investment required ranges from \$1,329,000 to \$3,135,000. From the \$70,000 Area Development Fee for three locations, \$40,000 is applied to the franchise fee for the first location, \$15,000 is applied to the franchise fee for the second location (and you will pay the remainder of the applicable franchise fee) and \$15,000 is applied to the franchise fee for the third location (and you will pay the remainder of the applicable franchise fee). An Area Developer may be granted a larger number of franchises for Franchised Restaurants if the Development Area selected will support the desired number of
